

**Mode Of Action**

Zeon 5 CS is a broad spectrum pyrethroid insecticide with contact and stomach action effective against a wide range of insect pest such as soil dwelling insect.

**DIRECTION OF USE**

**Target Pest:** Against cutworms and fire ants as soil treatment, fruitflies as bait spray  
**Crops:** Carrot, bean, maize, pea, potato, cowpea, mango, citrus, cabbage, cauliflower, brussel sprouts, okra, chinese cabbage, lettuce.

**DOSAGE:**

HA (600 L of water)	300 ml
Arp (250 L of water)	125 ml
Sprayer (20 L of water)	10 ml
Litre of water	0.5 ml
Soil drenching	1 ml/L
Fruit flies	2 ml when mixed with 20 ml protein hydrolysate.

**Mixing Instructions:** Thoroughly mix the recommended quantity of Zeon 5 CS in half volume of water, then agitate. Finally top up the tank to the required volume of water and maintain agitation during spraying.

**Interval between application:** 7 days with a maximum of 3 applications per crop cycle  
 Carrot, bean, maize, pea, potato, cowpea, mango, citrus (7 days), cabbage, cauliflower, brussel sprouts, okra, chinese cabbage, lettuce (3 days). Chilli, sweet pepper, tomato (5 days). Ginger, Litchi (14 days).
